4 First Aid Measures

Description of necessary first aid measures:

<u>Eye contact:</u> - Immediately flush eyes with plenty of water for several minutes. Remove contact lenses if present. Continue to rinse for at least 20 minutes. Get medical attention.

<u>Inhalation:</u> - Remove victim to fresh air and keep at rest in a position comfortable for breathing. Get medical attention.

<u>Skin Contact:</u> - Immediately remove all contaminated clothing. Rinse skin with water/shower for at least 15 minutes. Wash clothing before reuse. Get medical attention.

<u>Ingestion:</u> - Rinse mouth with water. Remove dentures if any. If material has been swallowed and the exposed person is conscious, give small quantities of water to drink. 5 Fire-fighting Measures

Extinguishing media:

Specific hazards arising from the chemical: This material is toxic to aquatic life. 6 Accidental Release Measures

Personal precautions, protective equipment and emergency procedures:

For non-emergency personnel: No action shall be taken involving personal risk or without suitable training. Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilled material. Avoid breathing vapour or mist. Provide adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Put on appropriate protective equipment.

For emergency responders: If specialized clothing is required to deal with the spillage, take note of any information in section 8 on suitable and unsuitable materials. See also information in "For non-emergency personnel".

<u>Environmental precautions:</u> Avoid dispersal of spilled material and runoff and contact with soil, waterways, drains and sewers. Inform the relevant authorities if the product has caused environmental pollution (sewers, waterways, soil or air). May be harmful to the environment if released in large quantities. Collect spillage.

Methods and materials for containment and cleaning up:

<u>Small spill:</u> Stop leak if without risk. Move containers from spill area. Dilute with water and mop up. Alternatively, absorb with an inert dry material and place in an appropriate waste disposal container. Dispose of via a licensed waste disposal contractor.

Large spill: Stop leak if without risk. Move containers from spill area. Approach release from upwind. Prevent entry into sewers, water

courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in a container for disposal according to local regulations (see Section 13).

7 Handling and Storage

Precautions for Safe Handling:

<u>Protective measures:</u> Put on appropriate personal protective equipment (see Section 8). Do not handle until all safety precautions have been read and understood. Do not get in eyes, skin or clothing. Do not ingest and avoid breathing vapour or mist. Keep in the original container or an approved alternative made from compatible material, kept tightly closed when not in use. Empty containers retain residue and can be hazardous. Do not reuse container.

Advice on general occupational hygiene: Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Workers should wash hands and face before eating, drinking and smoking. See also Section 8 for additional information on hygiene measures. Remove contaminated clothing and protective equipment before entering eating areas.

<u>Conditions for safe storage including any incompatibilities:</u> Store in accordance with local regulations. Store in original container protected from direct sunlight in a dry, cool and well-ventilated area, away from incompatible materials (see Section 10) and food and drink. Store locked up. Keep containers tightly closed resealed until ready for use. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Do not store in unlabeled containers. Use appropriate containment to avoid environmental contamination.
