Personal precautions, protective equipment and emergency procedures:

For non-emergency personnel: No action shall be taken involving personal risk or without suitable training. Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilled material. Avoid breathing vapour or mist. Provide adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Put on appropriate protective equipment.

For emergency responders: If specialized clothing is required to deal with the spillage, take note of any information in section 8 on suitable and unsuitable materials. See also information in "For non-emergency personnel".

Environmental precautions: Avoid dispersal of spilled material and runoff and contact with soil, waterways, drains and sewers. Inform the relevant authorities if the product has caused environmental pollution (sewers, waterways, soil or air). May be harmful to the environment if released in large quantities. Methods and materials for containment and cleaning up:

Small spill: Stop leak if without risk. Move containers from spill area. Dilute with water and mop up. Alternatively, absorb with an inert dry material and place in an appropriate waste disposal container. Dispose of via a licensed waste disposal contractor.

Large spill: Stop leak if without risk. Move containers from spill area. Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in a container for disposal according to local regulations (see Section 13).

Precautions for Safe Handling:

Do not ingest and avoid breathing vapour or mist. Keep in the original container or an approved alternative made from compatible material,

kept tightly closed when not in use. Empty containers retain residue and can be hazardous. Do not reuse container.
